## **OFFICIAL RULES**

## NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN.

The "Best Summer Ever" Vacation Giveaway (the "Sweepstakes") is open to participants in the United States and Canada (excluding Quebec) only. Void in Quebec and where prohibited or restricted by law. Further eligibility restrictions and rules of participation are contained in the Official Rules below.

This Sweepstakes is in no way sponsored, endorsed, or administered by, or associated with, Facebook. By entering, you understand that you are providing your personal information to Sponsor and not to Facebook.

- 1. DESCRIPTION: Internet access required. The Sweepstakes begins on Friday, June 18, 2021 and ends on Sunday, July 11, 2021 at 11:59:59 pm Eastern Time ("ET") (the "Entry Period"). The sponsor of this Sweepstakes is Massanutten Resort, 1296 Resort Drive, Massanutten, VA 22840 ("Sponsor").
- 2. ELIGIBILITY: Sweepstakes is open only to legal United States residents who are physically located and residing in the fifty (50) United States and Washington, D.C. and legal residents of Canada, excluding Quebec (each an "Entrant" and collectively "Entrants"). Entrants must be at least twenty-one (21) years of age at the time of entry. Entrants must be the rightful owner (or have authorized use) of the email address identified on the entry form. Employees, owners, shareholders, officers and directors of Sponsor and any entity involved in the administration of this Sweepstakes (collectively, the "Sweepstakes Entities"), and each of their respective parent companies, affiliates, divisions, subsidiaries, agents, representatives, promotion and advertising agencies together with the immediate family members and/or those living in the same household of such persons (collectively, "Household Members"), are not eligible to participate in the Sweepstakes. - 3. DISPUTE AS TO IDENTIFY OF ENTRANT. In the event of a dispute over the identity of an Entrant or potential winner in the Sweepstakes, the Entrant or potential winner will be deemed the authorized account holder of the email address associated with the entry. "Authorized Account Holder" is defined as the natural person in whose name the e-mail account was opened. limited to Entrant's full name, physical address and/or zip code, and email address, then click "Submit" to receive one (1) entry into the Sweepstakes. Limit of one (1) entry per person, during the Entry Period. If entries exceed the entry limitations, the Entrant may be disqualified, at the Sponsor's sole discretion. Entries generated by a script, macro or other automated means will be disqualified. Incomplete, unreadable, or unintelligible entries will be disqualified. Entries will not be acknowledged except as provided herein.

- 5. RULES ABOUT POSTS/ENTRIES: Entries will not be judged; however, entries must not include copyrighted, trademarked, patented, or previously published material or the personal information of any third party. Entries requiring license or usage rights from any third party are not eligible. Entries cannot defame or invade the rights or privacy of any person, living or deceased, or otherwise infringe upon any third party's personal, proprietary, or intellectual rights. Entries cannot contain illegal or unlawful material, and must not promote bigotry, racism, harm, or discrimination. Entries must be consistent with Sponsor's reputation in the marketplace and must be suitable for audiences of all ages.
